自暫准駕駛執照計劃於 2009 年 2 月 9 日擴展至私家車及輕型貨車後,任何人士在獲有關駕駛考試合格後,他須先申領暫准駕駛執照及完滿通過 12 個月的暫准駕駛期,才可申領私家車及/或輕型貨車的正式駕駛執照。根據現時香港有關法例,只容許持有香港法例第 374B 章 (道路交通《駕駛執照》規 例)附表四所列的國家/地區(參看以上(a)項)所發出的正式駕駛執照人士,透過「免試簽發」機制申領駕駛相關車輛的香港正式駕駛執照(電單車、私家車及輕型貨車);而只持有上述國家/地區所發出的非正式駕駛執照則不能透過「免試簽發」申領香港的正式駕駛執照。

Since the extension of the Probationary Driving Licence Scheme to private car and light goods vehicle on 9.2.2009, a person who has passed the relevant driving tests, is required to apply for a probationary driving licence, and upon satisfactory completion of the 12-month probationary driving period, is eligible for issue of a full driving licence for private car and/or light goods vehicle. According to the relevant ordinance, "direct issue" mechanism can only allow an eligible applicant with a full driving licence issued by any one of the countries/places listed under Schedule 4 of the Road Traffic (Driving Licences) Regulations, Cap. 374B (vide (a) above), to apply for a Hong Kong full driving licence of the respective vehicle class (motor cycle, private car and light goods vehicle). The "direct issue" mechanism is not applicable to those not holding a full driving licence or equivalent.

# 續領駕駛執照 RENEWAL OF DRIVING LICENCE

### 更改個人資料 CHANGE OF PERSONAL PARTICULARS

- (2) 運輸署署長在處理牌照申請時,可要求申請人出示其現時地址證明以及可在申請人出示該等證明之前,暫停處理該申請。因此,請申請人士帶同現時的地址證明,並在牌照事務處人員要求下,出示其地址證明;
- (3) 所有在本署以你的身分證明文件號碼登記的車輛牌照或駕駛執照的記錄,會根據你在本申請表內填報的地址而同時更改。
- (1) If a **change occurs in the name, address or identity document** of a driving licence holder/registered vehicle owner previously provided by the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing or by submitting the completed Transport Department Form TD559 with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certificate of Allocation of Personalized Registration Mark (if applicable) for amendment;
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** and may suspend the processing of the application until the production of such proof. Therefore, applicants please bring along your proof of present address for presentation as and when requested by officers of Licensing Office;
- (3) For any change of address notified in this application form, all vehicle/driving licence records of the applicant under the same identity document held by this Department will also be changed.
